



Town of Winnipeg Beach BY-LAW 01/2022

BEING A BY-LAW OF THE TOWN OF WINNIPEG BEACH TO REVISE AND UPDATE THE FEES AND CHARGES PAYABLE TO TOWN OF WINNIPEG BEACH FOR MUNICIPAL SERVICES RENDERED UNDER THE AUTHORITY OF THE MUNICIPAL ACT, THE PLANNING ACT, THE NOXIOUS WEEDS ACT, AND THE BY-LAWS OF THE TOWN.

WHEREAS the Council of the Town of Winnipeg Beach deems it advisable to include in one by-law the fees and charges payable to the Town of Winnipeg Beach for certain services rendered by officers and employees of the Town;

NOW THEREFORE the council of The Town of Winnipeg Beach in open session, assembled hereby enacts as a by-law as follows:

1. THAT this by-law shall be known as THE FEES AND CHARGES BY-LAW.
2. THAT the fees and charges payable to the Town of Winnipeg Beach for services rendered by officers and employees of the Town shall be as set out in the following schedules attached hereto:

Schedule "A" Public Works/Utility Department Fees and Charges
Schedule "B" Economic, Recreation and Community Services
Schedule "C" Finance, Administration and Legislation
Schedule "D" Miscellaneous and other Charges

3. THAT the fees and charges set out in the schedules attached to this by-law shall take precedence over any other by-law.
4. THAT any unpaid fees or charges owed to the Town by any taxpayer, including any penalties related thereto, as well as any fines imposed on the taxpayer by the court for contravention of the Town by-laws may be added to the taxes of the said tax payer and may be collected or enforced in the same manner as a tax as defined by The Municipal Act, L.M. 1996 c.58.
5. THAT By-Law 10/2019 to establish fees and charges, is rescinded.
